

## **PAAC June 2021 Report**

Sharing updates from Payer Advocacy Advisory Committee:

Please join me in thanking Dr. Betsy Peterson and Dr. Gene Hershorin for their 6 years of exemplary service to their colleagues as members of PAAC! With enormous gratitude.....THANK YOU!

A warm welcome and congratulations to Dr. Wyndolyn C. Bell and Dr. Kerry Fierstein who have been selected by the AAP Board to join PAAC and add their expertise! Welcome aboard and excited to have you both!

## **Highlights** from our activities:

- 1. PAAC continues to receive member concerns about UnitedHealthcare not including CPT code 87426 in their response to COVID-19 point of care testing underpayment. Conversations with UHC are ongoing.
- 2. PAAC is hearing increasing reports from members about downcoding or underpayment for E/M visits across payers. Please continue to report these through the Hassle Factor form as we work to strategize how best to assist practices. Realize that in our review to date, often the first level of appeal doesn't result in any material change. Practices who have had success have had to get to the 2<sup>nd</sup> or 3<sup>rd</sup> level of appeal to have their underpayment reversed.
- 3. Aetna has provided with us a new national Medical Director connection. Stay tuned for further collaboration.
- 4. The quarterly Pediatric Council meeting is scheduled for July 29<sup>th</sup>. - 5. Just brought to the attention of PAAC: UHC recently introduced an error in claims scrubbing that is rejecting some claims which contain 90471, and 90460 for their employer sponsored plans. Please look for errors as United Healthcare works on updating their system. Preliminary reports from members indicate they are aware and working to address.
- 6. PAAC has received reports that some payers are rejecting claims for COVID-19 vaccine for patients 12-15 years old. Please fill out a Hassle Factor form and attach a redacted EOB as an example if you are experiencing continued difficulties for this issue as we work with payers to adjust their claims processing appropriately.

- 7. PAAC has heard of payers' systems not being updated for new vaccines MenQuadfi and Vaxelis. Please report ongoing issues through the Hassle Factor form along with an example redacted EOB so we can address appropriately.
- 8. If you have Pay for Performance incentives that you believe payers based on 2020 data which does not represent normal activity, and in many cases was beyond your control, please reach out to Sue Kressly at skressly@kresslypediatrics.com
