# ANNOUNCING: THE SUDDEN UNEXPECTED INFANT DEATH (SUID) PREVENTION PROGRAM

The American Academy of Pediatrics was awarded the three-year cooperative agreement from the Health Resources and Services Administration (HRSA) Maternal and Child Health Bureau (MCHB) July 2022.

The AAP is partnering with the National Institute of Children's Health Quality (NICHQ) and the National Center for Fatality Review and Prevention (National Center) on this program with the overall goal of reducing the rates of SUID and reduce racial and ethnic disparities in SUID. The SUID Prevention Program has three priorities: establish a collaborative of national safe sleep organizations and stakeholders, increase pediatric providers' awareness and participation of child death review (CDR) and fetal and infant mortality review (FIMR) data, and create culturally-conscious, family-oriented safe sleep educational opportunities and resources for <u>AAP.org/safesleep</u>.

# PARTNER HIGHLIGHT: THE NATIONAL CENTER FOR FATALITY REVIEW AND PREVENTION



**Center for Fatality Review & Prevention** 

The American Academy of Pediatrics has partnered with the National Center for Fatality Review and Prevention (National Center) for this effort. The National Center is the federally funded technical support and data center serving Child Death Review (CDR) and Fetal and Infant Mortality review (FIMR) programs throughout the United States and affiliated territories.

#### WHAT IS CHILD DEATH REVIEW?

CDR is used to understand fatalities to improve safety. This multidisciplinary, community-oriented process brings together professionals to understanding how and why children die. This process uncovers disparities in how families are offered resources, access services, and navigate systems. It is a prevention-focused program that seeks to keep kids alive and illuminates where systems are successfully working. CDR focuses on the review of children 0-18 years of age and 21 years of age in some jurisdictions.

#### WHAT IS FETAL AND INFANT MORTALITY REVIEW?

FIMR is a multidisciplinary, community process that examines cases of fetal and infant deaths that is: comprehensive, de-identified, confidential, and gives voice to parents/families experience. It is a continuous quality improvement two-tiered process of data gathering, case reviews, and community action. The difference between CDR and FIMR is that FIMR includes a family perspective to foster greater commitments among teams and partners to champion greater health and racial equity in their communities. FIMR focuses on the review of stillbirths, and babies born live who do not survive until age 1.
