Pupillometry (Approved for CY 2023)

AAP requested new CPT code (replacing previous Category III code 0341T. Pupillometry provides non-invasive measurements of autonomic nervous system function which allows for objective documentation of pupillometry-specific autonomic deficit in a variety of disorders as well as objective measures of pupillary response to light in traditional examination and health care. No current method outside of pupillometry exists to provide such information in this manner (rapid, non-invasive, objective, accurate). With careful consideration of the multiple factors involved in the pupillary response to light, pupillometry can be effectively applied to many disorders in adults, children, and infants to ascertain details of sympathetic and parasympathetic components of autonomic nervous system function and simultaneously objectively document the pupillary response to light. Thus, pupillometry provides a new clinical application with an existing device. Pupillometers are operated by a physician or qualified health care professional and produce reliable results with minimal training.

COVID-19 Immunization Administration

The Academy led a multispecialty coalition in developing valuation recommendations for two (2) additional COVID-19 Immunization Administration (IA) codes:

0041A-0042A Novavax

Effective March 15, 2021, the Centers for Medicare and Medicaid Services (CMS) accepted the RUC recommendations, nearly doubling Medicare Physician Fee Schedule (MPFS) payment for administration of the COVID-19 vaccine, including administration of vaccines requiring two doses, to \$40 per administration.

0.40 Work Relative Value Units (RVUs)

0.73 Practice Expense RVUs

0.02 Professional Liability Insurance RVUs

1.15 Total RVUs

MPFS non-geographically-adjusted payment amount = \$40.00

This updated MFPS payment rate reflects the additional resources necessary to ensure the vaccine is administered safely and appropriately during the COVID-19 public health emergency. These expenses are described by the CPT Editorial Panel with the new CPT code 99072 and are now bundled into the new COVID immunization administration payments.
