Who, What, When, Where, Why, and How in Clinical Event Debriefing (WHiCED)

# **Purpose**

The American Academy of Pediatrics (AAP) Who, What, When, Where, Why, and How in Clinical Event Debriefing (WHiCED) Project Advisory Committee (PAC) is comprised of a diverse group of AAP members and advisors who coordinate, develop, and implement educational materials, data, and mentorship to promote evidence-based clinical event debriefing (CED) to improve the health and care of children. In alignment with WHiCED program goals and CED best practices, the WHiCED PAC works closely with AAP staff and leadership to develop educational materials, collect and analyze data, and support a mentorship program.

# **Vision**

To improve the care and health of children by providing a framework and tools for providers and healthcare staff to implement clinical event debriefing into practice.
