Dear Mr. President,

On behalf of the undersigned 144 national and state organizations who are dedicated to the mental health and well-being of infants, children, adolescents, and young adults, we write to thank you for the attention you and your administration have given to the youth mental health crisis in the U.S. This month marks the one-year anniversary of the declaration of a National State of Emergency in Children's Mental Health issued by the American Academy of Pediatrics, the American Academy of Child and Adolescent Psychiatry, and the Children's Hospital Association.ⁱ While much has been done by the federal government to address the crisis, the mental health of our nation's youth continues to deteriorate. We urge you to treat the youth mental health crisis as the national emergency it continues to be and declare a federal National Emergency in children's mental health.

Suicide is increasing for children and teens at alarming rates—especially for Black boys and girls under age 12-- and is now the leading cause of death for Asian American youth and the second leading cause of death for young people nationally.ⁱⁱ Emergency department visits for suspected youth suicide attempts have increased dramaticallyⁱⁱⁱ and those for eating disorders have doubled during the pandemic.^{iv} Meanwhile the numbers of young children diagnosed with anxiety, depression, and behavioral or conduct issues are growing at troubling rates.^v Systemic inequities such as racism, homophobia, transphobia, economic inequality, under-resourced schools, and medically underserved communities have disproportionately limited access to mental health services for young people from historically marginalized communities. Parents and caregivers are also trying to manage their own mental health needs while supporting their families in the face of economic, housing, and nutrition insecurity.

We applaud the mental health reforms outlined in your Unity Agenda during the State of the Union address and the commitment you have made to youth mental health in your budget to Congress. In addition, we are grateful for HHS Secretary Xavier Becerra's leadership on youth mental health and for the progress toward improved pediatric mental health care made by the Surgeon General, the Centers for Medicare and Medicaid Services, and other agencies throughout HHS.

However, our nation's youth, especially youth of color, need much more. Issuing a National Emergency Declaration would galvanize existing critical funding streams and support to help ensure that all children and adolescents can access the full continuum of mental and behavioral health care from promotion and prevention to early identification and treatment, especially in times of crisis. Of particular note, we need a robust and comprehensive mental health workforce strategy that prioritizes recruitment of underrepresented populations and ensures trained pediatric mental health and primary care professionals are adequately paid for the services they provide.

There is much more work to do by the Administration and in Congress. We urge you to join us in naming the youth mental health crisis exactly what it is--a National Emergency that requires all sectors to come together and take action.

We look forward to continuing to work with you to ensure all children receive culturally competent, developmentally appropriate, and trauma-informed mental health care without stigma. Thank you for your leadership on behalf of our nation's children.
