Call to Order and Introduction of Guests	Dr. Fernando Stein called the meeting to order at 8:00 am on Thursday, January 26, 2017. Guests were welcomed, and participants introduced themselves.	
Statement of Voluntary Disclosure	The Board of Directors reviewed the Academy’s policy on Conflict of Interest and Voluntary Disclosure. Board members were given an opportunity to disclose any direct or indirect financial interests, or any personal, family, or other relationships that conflict (or could have the appearance of conflicting) with their duties, responsibilities, or exercise of impartial and objective judgment with respect to the meeting’s agenda.	Conflicts were appropriately disclosed.
Approval of Minutes from the October 20-21, 2016 Board Meeting	The minutes of the October 20-21, 2016 meeting were reviewed, and approved with minor edits.	MOTION: Made, seconded, and unanimously carried to approve the minutes of the Board of Directors’ meeting on October 20-21, 2016.
Reports from AAP Committees, Councils and Sections	<u>National Nominating Committee (Michelle Fiscus, MD)</u> The NNC offered a spotlight session at the 2016 NCE designed to encourage members to seek out leadership roles in the Academy. It was reported that the session was not particularly well attended and the committee is trying to find a more suitable time and date in 2017. NNC has spent the past several months vetting President-elect candidates and will be formally interviewing the candidates next month. The NNC hopes to have time to meet with members of the Board of Directors at the upcoming 2017 ALF.	

Committee Forum Management Committee (Jerry Eichner, MD)

Dr. Eichner explained that several committees have been involved with the planning of sessions and workshops at the 2017 ALF that focus on committee mentorship and new member orientation. CoFMC members continue to develop new resources that they plan to post on the Lead@AAP website. Dr. Eichner thanked Dr. Denise Varasso for her service on the committee as she will rotate off this spring.

Section Forum Management Committee (Ann Stark, MD)

Dr. Stark reported that the SFMC is working hard to engage early career members and to improve the transmission of committee information. Dr. Stark explained that the SFMC has been asked to review a proposal for the merging of a section and committee into a council. She noted that merging entities could be a good way to consolidate intellectual and physical resources.

Surgical Advisory Panel (Constance Houck, MD)

Dr. Houck stressed that a goal of the SAP is to educate members on pressing pediatric issues. Currently, the SAP has focused many of their discussion on the topic of neurotoxicity. They are also working on the timeliness of surgery for children and opiate addiction among pediatric populations. SAP has worked closely with the committees and have formal liaison relationships with almost all of them.

Council Management Committee (Mark Del Beccaro, MD)

The CMC is in the process of obtaining balanced scorecards from the councils and continue to learn more about membership needs through this reporting mechanism. The scorecards make it clear that there is very important work taking place throughout the councils. The management committee will also be discussing succession planning at their upcoming meeting.

Chapter Forum Management Committee (Stephen Church, MD)

Dr. Church reported that in 2017 the CFMC moved up the date of the resolution deadline by one month. The committee was also making a concerted effort to reach out to authors who submit resolutions on topics that the AAP is already tackling. The group will work with authors refine resolutions and deter wordsmithing at the ALF. At the time of the resolution deadline, 68 resolutions had been submitted, but the committee was expecting additional late resolutions.

District Vice Chairpersons (Martha Middlemist, MD)

Dr. Middlemist reported that the 2017 cycle of Healthy People 2020 grants will focus on substance abuse. The committee will review applications and select award winners in May. At the upcoming ALF, the committee plans to interview Outstanding Chapter Award finalists and select winners per chapter size. The committee continues to refine the annual reporting process so that chapters can showcase their important work in the most efficient way.

Family Partnership Network (Julie Beckett)

	<p>The Family Partnership Network continues to engage family involvement at all levels. FPN is exploring opportunities for legislative advocacy training and engagement. The facilitated the Diverse Dads Webinar, which garnered the participation of 137 live attendees. The group is aiming to participate in webinars on a quarterly basis going forward.</p> <p><u>Section on Pediatric Trainees (Christian Pulcini, MD)</u></p> <p>Dr. Pulcini reported that the section executive committee had recently redesigned their leadership structure and are aiming to engage subspecialists. The section has developed an interactive text messaging system in order provide immediate responses to legislative news.</p>	
<p>CEO/Executive Vice President Report (Karen Remley, MD)</p>	<p>Dr. Remley provided a positive outlook on the financial, operational and programmatic state of the Academy. Her presentation included the following noteworthy information.</p> <ul style="list-style-type: none"> • Successful fundraising for the For Our Future campaign continues with cash and pledges received totaling nearly \$500,000 and another \$133,000 in verbal commitments. • Presently construction for the Headquarters of the Future is on time and on budget. • AAP has hired a new Chief Development Officer, Christine Bork, who will begin in March. • Currently membership is up 2.33% since 2016. The membership forecast for FY 16-17 is 67,354 which would be a net gain of just over 500 members from 2016. • As of December 31, 2016 the financial overall margin is better than the budget 2.7 million. • The total number and dollar value of Federal grants awarded to the AAP is growing while non-Federal total dollar value of grants shrinking. It is not yet known whether this is a trend that will continue into next Federal Administration. • AAP has developed a chapter-national communication plan is well underway that includes three components: an internal staff portal system; a weekly e-newsletter to chapter leaders; and an archive/document management system. 	
<p>Bright Futures 4th Edition Presentation (Fan Tait, MD)</p>	<p>Dr. Fan Tait reported that the fourth edition of Bright Futures is currently at the printer and should be ready for release soon. Highlights of the new edition include the following.</p> <ul style="list-style-type: none"> • The goals of Bright Futures continue to aim to: (1) Help health care providers shift their thinking to a prevention-based, family-focused, and developmentally-oriented direction (2) Empower families with the skills and knowledge to be active participants in their children’s healthy development (3) Foster partnerships between families, providers, and communities and (4) Work with states to make the Bright Futures approach the standard of care for infants, children, and adolescents

Committee Chairperson Appointments	The group discussed the nominees put forward for Committee Chairperson Appointment. Preferences were selected and were moved forward to the Consent Calendar for final approval.	
Board Workgroup Reports	<p>On Wednesday, January 25 the Board of Directors met in workgroups to discuss the establishment of four new Board level committees that will replace the previous advisory committee structure. Board members summarized draft descriptions for the four committees. They will continue to finalize in the coming month.</p> <ul style="list-style-type: none"> • Governance & Ethics Committee- The Committee will address governance matters of the board of directors including AAP constitution and bylaws, board policy and operations, board committee structure, organizational ethics, aligning strategy to policy, ensuring checks and balances, and outlining the roles and duties of AAP leadership and elected officers. • Policy Committee- The Committee will ensure that AAP policies are developed with the utmost integrity, remain a trusted resource for pediatricians and families, and are consistent with all other existing AAP policies. The committee will identify policy gaps and provide guidance to committees, councils, sections and task forces in the development of needed policies. • Finance, Audit and Development Committee- The Committee will ensure that all business operations and financial standing will leverage member value, improve the AAP's financial position by increasing non-dues revenue in the areas of services, and improve the AAP's financial position by consistently improving the quality and efficiency of all of the AAP's products, services, and publications. • Member Value and Engagement Committee – The Committee will be primarily directed to promote member value, monitor membership trends (total number, demographics, recruitment, retention), to provide guidance and leadership, and to advise on strategies aimed to engage a diverse membership.

Anticipated to be formally approved by the Board at the close of the meeting, Dr. Dreyer reviewed the plan’s main goals.</p> <ul style="list-style-type: none"> • To strengthen the Academy’s impact on child health through policy, advocacy, and education. • To enrich member value and engagement. • To broaden and diversify pathways for general pediatricians, pediatric medical subspecialists, pediatric surgical specialists, and trainees to exercise leadership within the Academy and the broader public sphere beyond pediatrics. • To enhance the Academy’s communication with members and stakeholders. <p>A correspondence was planned to be sent to all staff and members following the Board’s approval of the plan.</p>	
AAP Blueprint for the Federal Government Transition (Mark Del Monte, JD)	<p>Chief Deputy, Senior Vice President, Advocacy and External Affairs provided meeting attendees with a report on the AAP Federal Transition. He provided the following information.</p> <ul style="list-style-type: none"> • The Trump campaign was particularly successful because of the way it provided a global response to immigration, trade, and globalization, and performed well in economically depressed areas. • The new Administration espouses a populist message of “America First” with a strong focus on the decentralization of government, especially healthcare. • House Speaker Paul Ryan is proposing a repeal of Obamacare and replacing with Medicaid block grants or “per capita allotments.” • Through budget reconciliation, much of the ACA can be repealed and major cuts to the Supplemental Nutrition 	

	<p>Assistance Program (SNAP) or other mandatory programs can take place.</p> <ul style="list-style-type: none"> • It was recommended that members reach out to governors through AAP Chapters. It was noted that threats to health care access has mobilized many AAP members (500 new chapter contacts since Dr. Stein’s January all member e-mail).

<p>AAP Agenda for Children (Fernando Stein, MD)</p>	<p>Dr. Stein reported that since the 2016 NCE, the Advisory Committee to the Board on Strategic Planning (ACBOSP) has met via teleconference to consider proposals for new additions to the Agenda for Children as strategic priorities. Additionally, the full Board met to discuss the prioritization of three new themes:</p> <ul style="list-style-type: none"> • Addressing Bias/Discrimination and Promoting Empathy and Inclusion • Physician Health and Wellness • Addressing Violence against Children as a non-Communicable Disease <p>Staff developed an executive memo to provide background, demonstrate current AAP activities, and propose new initiatives related to the three priorities listed above. An implementation timeline and fiscal note was also included. The Board agreed that three themes should be prioritized and directed staff to move forward with implementation. The Board of Directors will establish a workgroup to review and propose an update to the current icon representing the Agenda for Children.</p>	
<p>Update: American Board of Pediatrics (Fernando Stein, MD)</p>	<p>On January 6, 2017, The Executive Committees of the American Board of Pediatrics (ABP) and the AAP met in Elk Grove Village to discuss the following topics</p> <ul style="list-style-type: none"> • General Pediatric Board Certification for International Medical Graduates with Completed Fellowships in US • Possible ABP Discount for AAP Members • MOCA-Peds • Ensuring Pediatric Board Certification stays relevant. <p>It was reiterated that AAP would like to see individuals who complete subspecialty fellowships to be able to sit for boards in Pediatrics without going back for 3 years for pediatric residency. In terms of discounted fees, ABP noted that for newly graduated individuals, their fee is waived for the first 5 years. Dr. Stein added that the executive committees of both organizations will meet again in the Spring to continue discussion.</p>

<p>AAP Operational/Program Updates</p>	<p><u>Staff Task Force on Subspecialty Members- Mary Lou White</u></p> <p>Following the October 2017 Board Meeting staff convened a task force to develop a more strategic, comprehensive approach to meeting the needs of subspecialist members. - Increase use of high quality, interactive learning and study materials
- Address requests of multiple AAP stakeholders

Most importantly, subspecialty PREP is valuable for members because it is designed to develop physician subspecialty knowledge, thereby giving them the foundational tools to improve the health of the children and families in their care. While there are many educational resources, PREP is distinguished by its highly interactive format that engages the pediatrician in learning and retaining subspecialty knowledge. It was decided that beginning July 1, 2017, the AAP will now offer subspecialty PREP as part of the fellow in training AAP membership package.

Quality Improvement Activities- Judy Dolins, MPH

Chief Implementation Officer, Judy Dolins provided a report on initiatives within the Division of Quality. Currently, there are four major areas of work being done.

1. Ensuring sound clinical policy
2. Planning for clinical policy dissemination and implementation at the point of care
3. Expanding MOC opportunities for members
4. Developing pediatric quality measures for practice that are relevant to child health and development

Ms. Dolins reported that the AAP is looking at validated measures that currently exist and are for payers to use regarding improvement at the physician level. It is anticipated that measures will evolve over time as gaps are improved. AAP will need to partner with the quality, payer and vendor communities to ensure measures are tied to payment and accessible through EHRs.

Executive Physician Leadership Program- David Bromberg, MD and Fan Tait, MD

Drs. David Bromberg, Anne Edwards, and Fan Tait attended a Kellogg Executive Physician Leadership Program at Northwestern University over two weekends in Fall and Winter of 2016. The program objectives were as follows:

- Enhance your leadership insights, style and abilities
- Explore methods for communicating a vision of purpose and values
- Foster positive relationships and reinforce strategic initiatives
- Drive teamwork and facilitate change

Additionally, the following session topics were offered:

- Leading High Impact Teams
- Leader as Coach
- Perspectives on Strategy: Tools, Techniques and Warnings!
- Leading with Vision and Purpose: What's Your Story?
- Uniquely Human Leadership
- Strategy Implementation and Change
- Negotiation
- Understanding Your Financial Position

The leadership delegation reported that the program featured experienced, distinguished faculty (nationally and internationally), inspiring presentations, innovative approaches to leadership and offered an open and excellent learning environment. However, it was noted that the expense was quite significant and that the program should be tailored more specifically to physicians.

Leadership Innovation Fostering Engagement (LIFE) Grant- David Jaffe, MD

Dr. David Jaffe, Senior Vice President, Education and Publishing, reported that the Leadership Innovation Fostering Engagement (LIFE) Fellowship Program is funded by a two-year grant (May 2016-May 2018) from the Physicians Foundation. The purpose of the LIFE program is to engage and support early career physicians (ECPs) in identifying and working towards their leadership development goals. Objectives include expanding leadership mentoring and support to ECPs looking to influence child health at the national level, stimulating professional growth and leadership development in ECPs, and deepening ECPs capacity to apply leadership skills by designing and completing AAP affiliated projects that advance the health of children and families. A Project Advisory Committee (PAC) consisting of nine AAP members with leadership expertise were chosen to help develop program content and mentor the ECPs selected to participate in the LIFE Program. Each Leadership Fellow is currently working on a professional development plan and project plan. Each of the fellows has been connected with at least one content mentor, who is a member of the AAP committee, section, or council related to his/her child health project and has committed to provide consultation and support. During the next phase of the grant cycle, Leadership Fellows are responsible for managing and implementing their child health projects. Leadership Fellows are expected to create a child health project deliverable such as a literature review, recommendations for action, a toolkit, a series of op-ed articles, or findings from a needs assessment.

Leadership Fellows will also write a short project narrative that describes the child health project, background on a leadership skill or competency, and personal reflection on learning and professional growth. They will use these narratives to outline presentations, which will occur at the closing seminar in December 2017.

NICU Verification- Ann Stark, MD and John Miller, MD

Dr. Stark and Mr. Miller provided an update with regard to the NICU Verification program activities that have occurred since the October 2016 Board Meeting. Attendees were reminded that verification participants must complete a Pre-review Questionnaire (PRQ). A site survey would follow where surveyors would review documents, interview staff, and tour the facility. The additional updates were provided:

- 10 sites contracted
 - 4 sites in contracting process
