Frequently Asked Questions (FAQ)

What are the goals/aims of the program?

- Increase knowledge, confidence, and skill in caring for the health of children in school-based settings to better support integration of mental and behavioral health care into primary care in school settings.
- Close gaps in access to mental health care for children and youth in school settings with the use of local Pediatric Mental Health Care Access programs.
- Encourage integrated care and collaboration with the school in promoting resilience and addressing mental health concerns.

What is ECHO?

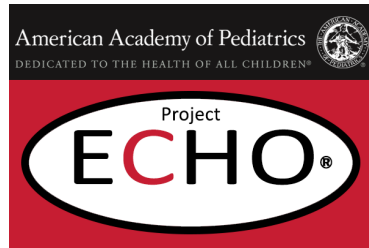
- Project ECHO is a telementoring program designed to create communities of learners by bringing together health care providers and experts in topical areas using didactic and case-based presentations, fostering an “all learn, all teach” approach.
- ECHO participants engage in a virtual community with their peers where they share support, guidance, and feedback. As a result, the collective understanding of how to disseminate and implement best practices across diverse disciplines continuously improves and expands.

Who is eligible to register for this ECHO?

- School-based health center staff, school health personnel and others caring for the health of children in school settings.

What are the benefits of participating?

- Enhance capacity to promote health development and resilience in school settings.
- Learn how to utilize local Pediatric Mental Health Care Access programs.
- Network and problem solve with individuals across the country.
- Earn Continuing Medical Education (CME) and Maintenance of Certification Part 2 (MOC2)!

What are the requirements to participate?

- Costs - There are no costs associated with participating in this ECHO series. This is a free training and technical assistance opportunity for participating organizations.
- Attendance - We encourage participants to attend all 6 sessions of the ECHO series.
- Session Participation - Participants are asked to actively engage and participate in each session. We strongly recommend having your video turned on during the ECHO sessions, specifically during the dedicated discussion time. This fosters a more interactive and engaging conversation.
- Case Presentation - All participants are encouraged to submit a case to present describing their experiences, challenges, and opportunities related to school-based health.
- Surveys - Participants will be asked to complete a post program survey after the ECHO series ends that help identify opportunities for improvements.

What is the frequency of the ECHO sessions and when do they occur?

- The ECHO sessions will occur 2x per month 2:00pm – 3:00pm CT/ 3:00pm – 4:00pm ET on the following dates:
 - Session 1: April 8, 2024
 - Session 2: April 22, 2024
 - Session 3: May 13, 2024
 - Session 4: May 29, 2024
 - Session 5: June 10, 2024
 - Session 6: June 24, 2024
