

2021 THRIVE COALITION STRATEGIC PLAN

INTRODUCTION

The Executive Committee of the Thrive Coalition met for three workshops facilitated by Unbounded Associates on June 23, June 29, and July 15, 2021. A full description of the process is contained in the document Thrive Coalition Strategic Planning Meetings – Summary of Discussion and Key Themes.

During the workshops, the Executive Committee focused their conversations on determining how they can push the Biden Administration to implement the Global Child Thrive Act (GCTA) and prioritize early childhood development (ECD) over the next 6-12 months, with additional activities planned on the horizon for the next 2 years. The Executive Committee selected three main areas in which to engage: Political Will & Engagement, Implementation Guidance & Indicators, and Funding. Each area is described in detail below.

The Executive Committee will check in on progress and adjust the strategy as follows:

- Regular bi-monthly meetings: Review and adjust immediate priority lists.
- Quarterly: Review accomplishments from previous quarter and add, remove, or shift the activities as needed. This will give the Executive Committee an opportunity to problem solve if an activity is not progressing as hoped. At this time, reviewing the "Opportunities to keep on radar" section will be helpful.
- Every six months, or upon election of new members: Do a full strategy review and make sure the activities and goals are still relevant. Complete the strategy for the next 6-month period which has not yet been planned (e.g., in January 2022, complete the strategy for July 2022-January 2023).

1. POLITICAL WILL & ENGAGEMENT

We will focus our advocacy efforts on getting the special advisor appointed, building relationships with top offices and officials, and furthering congressional and administration engagement on global early childhood development.

Success indicators in 6-12 months:

- Congress keeps ECD a priority and puts pressure on the Administration
- Special Advisor on Children in Adversity appointed
- Initiate high-level political signaling on global ECD through engagement with relevant political leadership/offices

- Consider other strategies to engage Congress and/or the Administration on global ECD such as events, briefings, etc.

2. DISSEMINATION AND TECHNICAL RESOURCES WORKSTREAM

We will disseminate information about the GCTA and seek to influence USG programming to include ECD through technical offices and missions by sharing good practices and evidence. We will lend expertise for technical guidance and indicator development, and provide input on policies and strategies, as needed.

Success indicators in 6-12 months:

- USAID's Children in Adversity office develops implementation guidance on the Global Child Thrive Act and shares widely within the agency.
- USAID bureaus and Missions include ECD language in their strategies, sector strategies, RFPs/RFAs, and CDCS.
- USAID develops standard indicators for child development informed by technical input from the Coalition.

3. FUNDING

We will meet with OMB (Foreign Assistance Bureau) and continue to meet with champions on the Hill, pushing for an increase in the Vulnerable Children account as at a catalyst but also seeking ECD embedded in funding across the accounts.

Success indicators in 6-12 months:

- Increase to the Vulnerable Children account in FY22 and FY23
- Inclusion of Thrive report language in final appropriations bill
- USG defines and funds new and existing projects featuring inclusive ECD
- Increase to accounts that support global ECD (Nutrition, MNCH, WASH, Education, UNICEF)
